# **REGULATION**

We hope your study holiday in Rimini can be one of the most enjoyable experiences to remember. The Management, represented by Ms. Monica Golfieri, is always available to provide you with all the information and assistance for any type of need.

We invite you to promptly report any detail that may cause you discomfort.

Please read the following rules:

#### Lesson timetable

Start at **9:00 AM** Coffee break from 10:45 AM to 11:00 AM End at **1:00 PM**Start at **2:30 AM** Coffee break from 4:15 PM to 4:30 PM End at **6:30 PM** 

For the regular running of the programs, the punctuality of the start of lessons is essential, **those** who arrive with unjustified delay will have to enter the class after the break.

In the event that the class does not reach a minimum number (3 students), the management reserves the right to reduce the hours of lessons. **In case of illness**, to make up for any missed lessons, it is essential to **show a medical certificate**. Any absences or delays repeated frequently will be communicated to the Management who will notify the parents if the student is a minor.

# **Payments and Refunds**

- PAYMENTS MUST BE MADE WITHIN THE FIRST DAY OF SCHOOL.
- No refunds are provided in the event of postponed starts or early departures, as well as missed lesson hours without notice.

For the request of Student Visa, the total amount of the course fees will not be refunded in case of visa denial. This sum will be available to the student to attend the course over the next 2 years.

### **Choice of courses and Final Test**

Tiberius provides a textbook and / or any photocopies for the lessons.

Additional requests for material are charged to the student.

Once the course has been booked, it is no longer possible to change the type of course chosen. Any changes in study levels are also at the discretion of teachers. To take the final test and thus obtain the diploma, it is necessary to have attended eighty percent (80%) of class hours. The candidate must sign the consent to take the test.

<u>Final exams are strictly held on THURSDAY</u> of the last week of attendance at the courses, from 9:00 AM to 11:00 AM or from 3:00 PM to 5:00 PM indiscriminately for all levels. **The use of any electronic device is not allowed** during the tests, if the student is found to use it anyway, the test will be canceled.

During the study period, verification tests will be carried out at the discretion of the teacher.

#### Behavior of the student

Students are required to have a **polite and decent behavior**, teachers reserve the right to remove from lessons anyone who disturbs the performance of the teaching activity.

#### **Extracurricular activities**

The programs of extracurricular activities are announced at the beginning of the week. Upon joining, payment is required to guarantee participation, according to the methods that will be established. In case of non-participation, the fees are non-refundable.

# **Common and Personal Property**
